INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the ALOYSIUS 34-03 wellhead cut and cap and will be conducted for flowline abandonment. Approximately 752' of flowline will be abandoned-in-place. The ECMC will be updated in a supplemental Form 27 if a portion of the flowline is able to be removed. The wellhead was cut and capped per ECMC rules and soil samples were field screened at the N-E-S-W sides of the wellhead. Additionally, soil samples will be collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample was collected at the base of the wellhead excavation. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples will be analyzed by a certified laboratory for the full extent of Table 915-1. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

If groundwater is encountered during the remedial excavation or site investigation activities, a grab groundwater sample will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1.

Additional Investigative Actions

Visual inspection of the flowline area will occur during abandonment activities. Field personnel will field screen all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling is required. The ECMC Flowline Closure Checklist will be utilized and filled out during the abandonment process. A photolog will be submitted on the Subsequent Form 27. Exceedances of the pH, arsenic, barium, lead, and selenium Table 915-1 standards will require the delineation of the exceedances and the collection of background samples upslope of the wellhead to compare analytical results.

The material excavated during the cut and cap operations was used as backfill for the excavations.

The implementation schedule has been changed due to the decommissioning of the ALOYSIUS 34-3 wellhead, the future flowline decommissioning, and the necessity to complete a supplemental site investigation to investigate ECMC Table 915-1 inorganics in native soil. The schedule for the proposed site investigation will be provided in the subsequent Form 27.

OPERATOR COMMENT

This form has been submitted to provide a 1Q2025 timeline update for the ALOYSIUS 34-3 (REM #23372). No work has been completed since initial investigation. Supplemental site investigation (SSI) activities are required to evaluate ECMC Table 915-1 inorganics in native soils.

Remediation and site investigation, previously directed by Entrada Consulting Group (Entrada), is now under the direction of Montrose Environmental (Montrose). Montrose is working with Noble to establish a site investigation schedule which will be proposed in a subsequent Form 27 in 2Q2025.

Quarterly reporting will be conducted until closure criteria are achieved for the remediation project.
