On 9/9/2025, Cornish 17-11 tank battery decommissioning activities were completed. During the completion of the activities, no potential presence of impacted material(s) was observed/smelled. Consistent with Rule 912, samples were collected and analyzed to determine whether any constituents are present at levels in excess of Table 915-1 standards. Final laboratory analytical results received on 9/26/2025, indicate the soil samples, AST01, discovered beneath the aboveground storage tank, exceeded ECMC Table 915 standards for Total TPH at 786 mg/kg. Groundwater was not encountered during decommissioning activities. Final analytical results will be included as part of the Supplemental Form 19 submission.
