Describe what is known about the spill/release event (what happened -- including how it was stopped, contained, and recovered):

On 09/10/2025, UPRC-65N64W 23SESW tank battery investigation activity was completed. During the completion of the activities, no potential presence of impacted material(s) was observed/smelled. Consistent with Rule 912, samples were collected and analyzed to determine whether any constituents are present at levels in excess of Table 915-1 standards. Final laboratory analytical results received on 9/25/2025, indicate the soil sample, EPWVN01, discovered at the eastern produced water vessel exceeded ECMC Table 915 standards for 1-Methylnaphthalene at 0.021 mg/kg, 2-Methylnaphthalene at 0.045 mg/kg, and Naphthalene at 0.004 mg/kg. Groundwater was not encountered during tank battery resampling activities. This location is within 300 feet of waters of the state.
