In accordance with COGCC Rule 911, this form serves as notification for the abandonment of the Miller 1-7 wellhead. The ground and sub-surface soil will be visually inspected for impacts during abandonment activities. Field observations will be recorded in a field inspection form for submittal to the COGCC. To note this well was dug up and re-entered by the current operator, with cement plugs drilled out using fresh water, unsuccessfully tested, and now is being permanently abandoned. The well was not produced nor flowlines installed in this effort.
