Comment:

Pursuant to Resolution #404363838, weeds were removed and disposed of properly, and Location reseeded.

Noxious weeds (Halogeton) remain established on the Location, and have not been removed or disposed. Unclear if alternative management methods (such as herbicide) were implemented, however many plants have reached viable maturity and are flowering.

Additionally, unable to observe evidence that seeding efforts have occurred; drill rows associated with drill seeding not observed, and no seed was observed on the soil surface if broadcast seeding was performed.

Unable to find evidence that work was performed.

Corrective Action:

Pursuant to Rule 210, submit documentation of weed management and reclamation efforts conducted. At a minimum, include details/information such as specific work performed, invoices, seed tags, etc...
