INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the HOFFMAN C02-65HN wellhead cut and cap and flowline removal. The wellhead was cut and capped per ECMC rules on 09/26/2024. However, the confirmation soil samples collected during wellhead cut and cap activities were determined to have insufficient material when delivered to the laboratory and were not analyzed. Resampling will be conducted. The results of this environmental assessment will be summarized in a subsequent supplemental Form 27 submittal. Approximately 330' of flowline was removed by Tasman Geosciences Inc. on 10/17/2024 and decommissioning activities were summarized in Supplemental Form 27 #403996501.

The confirmation soil samples collected during wellhead cut and cap activities were determined to have insufficient material when delivered to the laboratory and were not analyzed. Resampling will be conducted. Soil samples will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. Background soil samples will be analyzed by a certified laboratory for analysis of metals per ECMC Table 915-1 and soil suitability parameters including pH, EC, SAR, and boron. All sample analysis was/will be performed by a certified laboratory using approved ECMC laboratory analysis methods.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

If groundwater is encountered, a grab groundwater sample will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB, chloride and sulfate anions and total dissolved solids (TDS).

Visual inspection of the wellhead and flowline areas occurred during abandonment activities. Field personnel screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling is required. The ECME Flowline Closure and Wellhead Closure Checklists were utilized and filled out during the abandonment process.

The confirmation soil samples collected during wellhead cut and cap activities were determined to have insufficient material when delivered to the laboratory and were not analyzed. Resampling will be conducted.

Noble plans to conduct background soil sampling from at least three boring locations at similar depths and soil horizons as confirmation soil samples, in areas away from oil and gas infrastructure to further investigate residual inorganic concentrations in soil at the wellhead.

Facility closure activities and confirmation soil sampling were conducted at the wellhead and flowline on 09/26/2024 and 10/17/2024, respectively and were summarized in Supplemental Form 27 #403996501.

The confirmation soil samples collected during wellhead cut and cap activities were determined to have insufficient material when delivered to the laboratory and were not analyzed. Resampling will be conducted. The results of this environmental assessment will be summarized in a subsequent supplemental Form 27 submittal.

Noble plans to conduct background soil sampling from at least three boring locations at similar depths and soil horizons as confirmation soil samples, in areas away from oil and gas infrastructure to further investigate residual inorganic concentrations in soil at the wellhead.

Pursuant to Rule 913.e, quarterly reporting will continue for the location until data indicates no further action is warranted.
