COMMENTS:

TEP Rocky Mountain LLC (TEP) is submitting this Form 4 to satisfy a request from ECMC engineering staff to provide an update regarding the status of a historically approved bradenhead Pressure Management Plan (PMP) and summarize the current well condition. There is no Condition of Approval (COA) associated with this submittal, as this Form 4 submittal was requested by ECMC engineering staff via electronic communications and in-person meetings. An annual bradenhead test, which included a seven-day shut-in of the bradenhead connection to the flow line, was performed on 5/28/2025, and the Form 17 reporting the results of this test can be referenced under ECMC Document #404226625.

Since installation, the bradenhead connection to the to the flowline is effectively managing the bradenhead pressure and maintaining a consistent bradenhead pressure below the Bradenhead Monitoring Area (BMA) threshold pressure of 150 psi. TEP has included the historical monthly pressure data as an attachment.

TEP has completed an additional diagnostic evaluation of the well, and the following lines of evidence continue to demonstrate conclusively that the GIBSON GULCH UNIT 5-31B has both casing integrity and wellbore isolation:

- The recent bradenhead test results indicate a successful test, and the test results confirm production casing integrity.
- There was a 70-psi pressure differential between the surface casing and the production casing prior to starting the bradenhead test, with the surface casing pressure being lower than the production casing pressure.
- The bradenhead pressure decreased to 0 psi in 5 minutes with a de minimis volume of gas through a two inch.
- The recent analytical results indicated a carbon dioxide concentration of 0.2358% in the production gas sample versus a concentration of 0.0144% in the bradenhead sample. The analytical results of the recent bradenhead and production gas samples have been submitted to the ECMC via a Form 43 (404376422).

TEP will continue to utilize the GIBSON GULCH UNIT 5-31B bradenhead connection to the to the flowline to effectively manage the bradenhead pressure below the BMA threshold pressure as detailed in the previously approved Pressure Management Plan. TEP will also continue to monitor the bradenhead pressures as part of our monthly monitoring and annual testing programs and will report any future bradenhead threshold pressure exceedances as required by Rule.
