A site investigation was conducted pursuant to ECMC Rule 911 at the MILLAGE T4N-R64W-S12 L02 Tank Battery location.

Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the separator(s). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

One background soil sample (BKG01@6") was collected from an area not impacted by oil and gas development and analyzed for Table 915 Soil Suitability constituents (pH, EC, SAR, and Boron) and metals. Background concentrations of SAR, EC, As and Ba exceeded the Table 915-1 soil standards.

Is further site investigation required?

Elevated inorganics and metals were observed in multiple locations at the former MILLAGE C-64N64W 12SENW Tank Battery. Soil will be resampled and analyzed for pH at the W AST01@6.0", S SEP01@3.0', PWVB02@6.0', PWVN02@5.0' sample locations, and soil will be resampled and analyzed for pH and SAR at the N DL01@5.0' sample location at the same depths where the initial elevated pH and/or SAR concentrations were observed. Noble will request an NFA be granted if the reanalyzed samples are within the Table 915-1 concentration range.

Alternatively, if the resampled results are do not comply with the Table915-1 standards five background samples will be collected from similar depths and lithologies to characterize native soil and be used to attribute elevated inorganics concentrations to native soil conditions. See attached for proposed sample locations. If elevated concentrations cannot be attributed to native soil conditions via background soil characterization the Operator will submit a detailed reclamation plan and will request NFA designation be granted under Rule 915.b: Request to leave elevated inorganics in situ.
