On 8/26/2025, Gollner O27-02 wellhead and flowline supplemental site investigation (SSI) activities were completed. During the completion of the activities, no potential presence of impacted material(s) was observed/smelled. Consistent with Rule 912, samples were collected and analyzed to determine whether any constituents were present at levels in excess of Table 915-1 standards. Final laboratory analytical results received on 9/18/2025, indicate the soil sample, 32225-FL-07-N-SO-4-20250826, discovered along the flowline exceeded ECMC Table 915 standards for 1-Methylnaphthalene at 0.007 mg/kg. Groundwater was not encountered during decommissioning activities. Operator was notified of this release on 10/8/2025 and acknowledges that 24 hour notification was not submitted within 24 hours of the receipt of the results. This location is located within the Municipality of Milliken. All data collected will be submitted with the next quarterly Supplemental Form 27 for REM 32225.

Further, this facility is no longer active and is in the process of being decommissioned. The compromised flowline has been taken out of service and there is no longer a possibility of a release originating from this infrastructure.
