INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the WELLS RANCH USX AE19-07 wellhead cut and cap. The wellhead was cut and capped per ECMC rules on 9/22/2025. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Final analytical results are pending and will be summarized in a subsequent Supplemental Form 27 submittal. The flowline was previously abandoned on 9/10/2018, and the ECMC was notified on Form 44 Document #402094463.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. A grab confirmation soil sample was collected at the wellhead excavation, and soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Visual inspection of the wellhead area occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling was required. The ECMC Wellhead Closure Checklist was utilized and filled out during the abandonment process. The ECMC Wellhead Closure Checklist and a photolog will be submitted on the Subsequent Form 27.

The lithology between the site and background locations was observed to be well and poorly graded sands. Final analytical results are pending and will be summarized in a subsequent Supplemental Form 27 submittal.

This Form 27 is being submitted to include a 4Q 2025 update for the WELLS RANCH USX AE19-07 wellhead (REM #42043) and the decommissioning results at the former wellhead location. The wellhead was cut and capped on September 22, 2025. Final analytical results are pending and will be summarized in a subsequent Supplemental Form 27 submittal.

Three background soil samples were collected from near the wellhead and analyzed for Table 915-1 metals in soil and Soil Suitability for Reclamation parameters per ECMC Table 915-1. The background soil samples were collected from a depth of 3.5 feet below ground surface (ft bgs). The lithology between the site and background locations was observed to be well and poorly graded sands. Final analytical results are pending and will be summarized in a subsequent Supplemental Form 27 submittal.

Pursuant to Rule 913.e, quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The results of the supplemental site investigation will be submitted on a subsequent Form 27.
