Describe what is known about the spill/release event (what happened -- including how it was stopped, contained, and recovered):

On 6/26/2025, the potential presence of impacted material(s) was identified via hydrocarbon odor during decommissioning activities at the Lundvall-65N66W 18NESW tank battery, soil samples: PWV01, PWV01-N and PWV01-W located at the produced water vessel excavation. Final laboratory analytical data indicated a historical release was discovered beneath the produced water vessel. PWV01, PWV01-N, exceeded ECMC Table 915 standards for xylene at 10.3 mg/kg, 1,2,4-trimethylbenzene at 9.43 mg/kg, 1,3,5-trimethylbenzene at 6.07 mg/kg, naphthalene at 2.85 mg/kg & 0.008 mg/kg, TPH at 627 mg/kg, fluorene at 0.699 mg/kg, 1-methylnaphthalene at 4.20 mg/kg, 0.015 mg/kg, 2-methylnaphthalene at 12.9 mg/kg, 0.039 mg/kg. Groundwater was not encountered during decommissioning activities. This within 300 feet of water of the state and is located within the municipality of Greeley. The supplemental Form 27 has been submitted for remediation number 37191, document number: 404258378.
