The implementation schedule has been changed due to the necessity for supplemental site investigation activities adjacent to the wellhead and the flowline.

OPERATOR COMMENT

This form is being submitted as a third quarter timeline update for the Shable Federal LB33-78HN wellhead and flowline.

A historic release was discovered at the wellhead during decommissioning activities on July 29, 2025. The ECMC was notified of the historic release in Form 19 # 404313193. Pending review of analytical data, the associated Supplemental Form 27 will be submitted within 90 days of decommissioning activities.

Flowline decommissioning activities were completed by Tasman Geosciences Inc. and will be summarized in a subsequent Supplemental Form 27 submittal.

Pursuant to Rule 913.e, quarterly reporting will continue for the location until data indicates no further action is warranted.
