On 1/24/2025 a site investigation was conducted pursuant to ECMC Rule 911 at the WADE T8N-R59W-S29 L01 Facility and Tank Battery location.

Grab confirmation soil samples were collected from the produced water vessel(s) excavation (PWV01-B@6', PWV01-N@2.5', PWV01-E@2.5', PWV01-S@2.5', and PWV01-W@2.5'), beneath the ground oil tank(s) (AST01@0-6", AST02@0-6", and AST03@0-6"), at the risers for the flowline (s) and dumphine of any separator (SEP01-FL@5', SEP01-DL-OIL@2,5', and SEP01-DL-WATER@2.5'). In addition, the on-site dump line located between the separator and tank battery was removed by pulling from either end. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Additional Investigative Actions

Visual inspection at the tank battery area occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses. Additionally, discrete soil samples were collected from the base of the excavation and excavation sidewall in areas most likely to be impacted and exhibiting the highest field screened VOC concentration. A detailed summary of tank battery decommissioning activities, including field notes, site photos, figures, and laboratory analytical results, was attached to a previous Supplemental Form 27 (ECMC Document #404179592).

On 01/27/2025, five background soil samples were collected from one discrete location (BKG01) adjacent to the tank battery and analyzed for metals in soil per ECMC Table 915-1, pH, SAR, EC, and boron. Background soil samples were collected from depths ranging between 0.5 to 6 feet below ground surface (ft bgs) and the lithology between the site and background locations were observed to be lean clay. The maximum background concentration for pH was observed to be 8.82. The maximum background concentrations with the 1.25x multiplier applied for arsenic, barium, cadmium, and lead were calculated to be 1.46 mg/kg, 601 mg/kg, 0.250 mg/kg, 13.0 mg/kg, respectively. All barium concentrations observed during decommissioning activities were below background levels.

A supplemental site investigation (SSI) will be completed to vertically and horizontally delineate the pH exceedances observed at sample locations GS02@0.5', AST03@0.5', PWV01-E@2.5', and PWV01-B@6', during decommissioning. During the SSI, soil samples will be collected and analyzed for full ECMC Table 915-1 constituents. Concurrently with the SSI, additional background samples will be collected to determine if pH, arsenic, cadmium, and lead are attributed to native soil conditions at the site. The SSI will be completed in accordance with the proposed implementation schedule and attached site investigation plan. The results of the SSI will be submitted on a subsequent Form 27.

OPERATOR COMMENT

This Form 27 is being submitted as 3Q25 timeline update and to update the remedial strategy at the Wade-68N59W 29NWNE Tank Battery location.

A supplemental site investigation (SSI) was proposed to delineate the pH, arsenic, cadmium, and lead exceedances during decommissioning on the previous SF27 (ECMC Doc #404179592) which is still in process as of the submittal of this form. An updated proposal to delineate the pH exceedances observed at soil sample locations GS02@0.5', AST03@0.5', PWV01-E@2.5', PWV01-B@2.5' during decommissioning and to collect background samples to determine if pH, arsenic, cadmium, and lead are attributed to native soil conditions at this site is presented in the site investigation report section of this Form 27. The updated proposed soil boring locations are illustrated on the attached proposed site investigation plan.

The implementation schedule has not changed from the schedule submitted in Form 27 #404179592. The proposed SSI is expected to commence in the fourth quarter of 2025. The ECMC will be notified in a subsequent Form 27 should the implementation schedule be updated.

The results of the proposed SSI will be submitted on a subsequent Form 27. Quarterly reporting will be conducted until closure criteria are achieved for the remediation project.
