INITIAL ACTION SUMMARY

Pursuant to ECMC Rule 911, a site investigation was conducted pertaining to the former LF Ranch 64N63W 17NWN facility and tank battery location.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Grab confirmation soil samples were collected from the base of the produced water vessel excavation (FS01@5') and the sidewall with the highest field screening concentration (SS04@2.5'), beneath the ground oil tanks (AST01@0.5' & AST02@0.5'), and at the risers for the flowline (SEP01-FL@3') and dumpline (SEP01-DL@3') at the separator. Additional field screening samples were collected from the meter house (MH01@0.5') and flare (Flare01@0.5'). Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Were background samples collected as part of this site investigation?

Fifteen background soil samples were collected from five discrete locations (BG01 through BG05) near the flowline and analyzed for arsenic. Background soil samples were collected from depths ranging between 0.5 to 5 feet below ground surface (ft bgs). The maximum background concentration with a 1.25x multiplier applied for arsenic was observed to be 2.40 mg/kg. All soil samples were within background concentrations for arsenic except AST01@0.5' (3.33 mg/kg). Additional background soil samples (5) were collected on 07/30/2025 from soil of native/similar lithologic material not impacted by oil and gas activity to further compare EC, SAR, pH, boron, and ECMC Table 915-1 metals, as needed. Analytical results are currently pending and will be submitted on a subsequent Form 27.
