INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the Bashor PC AA17-21 wellhead cut and cap. The wellhead was cut and capped per ECMC rules. Laboratory analytical results indicated a historical release occurred at the decommissioned wellhead. Please refer to the operator comments for additional information regarding the historical release and remedial efforts to be conducted at the wellhead.

The flowline was previously abandoned on 12/5/2018, and the ECMC was notified on Form 44 Document number 403689007.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample was collected from the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Following source mass removal of hydrocarbon impacted soil, confirmation soil samples will be collected from the final extents of the excavation. Soil samples will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB by EPA Method 8260, chloride and sulfate anions by EPA Method 300.0, and total dissolved solids (TDS) by Method SM 2540C.

Visual inspection of the wellhead area occurred during decommissioning activities. Six site specific background soil samples were collected from approximately 4 ft. and 6 ft-bgs from three soil borings (BKG01 through BKG03) in areas away from oil and gas infrastructure from similar depths and soil horizons as confirmation soil samples and were submitted for analysis of pH, EC, SAR, and total metals (Table 915-1 List) by ECMC approved methods. Wellhead decommissioning activities and confirmation soil sampling at the Bashor PC AA17-21 wellhead occurred on March 25, 2025. Laboratory analytical results indicated a historical release occurred at the Bashor PC AA17-21 decommissioned wellhead and was reported as a historic release in Form 19 document number 404141336. Hydrocarbon impacted material at the wellhead will be removed and hauled to a permitted disposal facility. Final analytical results will be summarized in a subsequent Supplemental Form 27 submittal and will be reported along with ongoing Remediation Project Number 38925.

Based on the discovery of historic hydrocarbon impacts at the wellhead, source mass removal activities will be initiated as soon as possible. The implementation schedule has been updated to reflect these changes.

OPERATOR COMMENT

This Supplemental Form 27 was prepared for the historic release that was discovered at the Bashor PC AA17-21 wellhead and in connection with the initial Form 19 submitted under Document 404141336.

Discrete soil samples were collected from beneath the wellhead, WH01@6, and from the sidewall with this highest screening, WH01-N@4. All analytical results for soil samples submitted for analysis are compliant with their respective Table 915-1 Protection of Groundwater Soil Screening Levels, below the highest background concentrations for pH (8.76), or below 1.25x the highest background concentrations for arsenic (1.51 mg/kg), except for 1,2,4-trimethylbenzene in WH01-N (0.086 mg/kg), 1,3,5-trimethylbenzene in WH01 (0.014 mg/kg) and WH01-N (0.081 mg/kg), and pH in WH01-N (9.13). Groundwater was not encountered during excavation of the wellhead for decommissioning activities.

Supplemental source mass removal activities will be initiated via mechanical excavation as soon as possible.

The flowline was previously abandoned on 12/5/2018, and the ECMC was notified on Form 44 Document number 403689007.

The data were reviewed for compliance with the analytical method and the associated quality assurance/quality control (QA/QC) procedures. Chain of custody forms were properly executed, and data were reported using the correct methods and reporting units. The results of the QA/QC assessment indicate that data precision and accuracy are acceptable.

Pursuant to Rule 913.e, quarterly reporting will continue for the location until data indicates no further action is warranted.
