INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the SHABLE USX AB11-14P flowline removal. Approximately 2,360' of flowline was removed, however a portion of the flowline was abandoned-in-place due to field constraints. The ECMC was updated in a supplemental Form 27. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. So as to not disturb the area of field constraint, soil samples were taken at the start and endpoint of the flowline where the area exists. Soil samples were also taken along the flowline any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. The Flowline Pre-Abandonment Notice Document number was previously included under Related Forms.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Grab confirmation soil samples were collected along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods. A grab confirmation soil sample was collected at the wellhead excavation in base of the excavation or the area showing the highest degree of impact during

Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling was required. The applicable ECMC Closure Checklists were utilized and filled out during the abandonment process. A photolog was attached.

Fifteen background soil samples were collected from an area not impacted by oil and gas development and at similar depths and lithologies as confirmation soil samples collected at the location and analyzed for Table 915-1 metals and SSR constituents. Background soil sample analytical results were reported with elevated levels of pH, EC, SAR, Arsenic (As), Barium (Ba), Cadmium (Cd), Lead (Pb) and Selenium (Se).

Is further site investigation required?

Elevated pH was observed in multiple locations at the former Shable USX AB 11-14P flowline. Soil will be resampled and analyzed for the full Table 915-1 analyte suite at the 14FL09@5.0' and 14FL11@4.0' and 14FL14@6' sample locations at the same depth where the initial elevated pH concentrations were observed. Noble will request an NFA be granted if the reanalyzed samples comply with the Table 915-1 concentration standard. Background samples will be used to justify elevated concentrations.

Alternatively, if the sample results exceed the Table 915-1 standards and cannot be attributed to native soil conditions via background soil characterization a minimum of five additional samples will be collected to delineate the magnitude and extent of elevated constituents.

Following completion of the delineation, Noble will submit a detailed reclamation plan to address elevated SSR constituents that includes, but is not limited to, soil analysis from adjacent undisturbed lands, revegetation techniques, site stabilization, and details of seeded species and will request NFA designation be granted under Rule 915.b: Request to leave elevated inorganics in situ.

In addition, Additional background samples will be collected in five locations from an area not impacted by oil and gas development at similar depths (3', 4', 5', 6', 7', 8' and 9') and lithologies as confirmation samples collected at the location and analyzed for ECOM Table 915-1 metals and soil suitability for reclamation standards (SSR) (pH, EC, SAR, and Boron).

SOURCE REMOVAL SUMMARY

Describe how source is to be removed.

The organic compound exceedances observed at sample location 14FL01@4.5' were removed through a remedial excavation. Remedial excavation confirmation soil samples were collected and analyzed for full ECMC Table 915-1 constituents. The impacted soil was disposed of at an approved landfill as non-hazardous waste in accordance with Rules 905 and 906. Copies of the waste manifests are available upon request.

The organic compound exceedances observed at sample location WH-SS-01@7', WH-SS-03@7', WH-FS-01@8' will be removed through a remedial excavation. Remedial excavation confirmation soil samples will be collected and analyzed for full ECMC Table 915-1 constituents. The impacted soil will be disposed of at an approved landfill as non-hazardous waste in accordance with Rules 905 and 906. Copies of the waste manifests will be available upon request.

REMEDIATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Laboratory analytical results indicated a historical release had occurred at the location of soil samples 14FL01@4.5', WH-SS-01@7', WH-SS-03@7', WH-FS-01@8' and was reported as a historic release in Form 19 document numbers 4403612669 and 403660699.

The source was excavated at the Shable USX AB 11-14P wellhead flowline riser location (14FL01@4.5') and confirmation soil samples were collected and analyzed for the full Table 915-1 suite. Additional excavation is needed to remove impacts observed at seven-and-eight feet in the Shable USX AB 11-14P former wellhead location. Elevated concentrations of Table 915-1 soil suitability for reclamation (SSR) constituents and Table 915-1 metals observed in the flowline riser excavation confirmation samples will be removed via excavation during impact removal at the adjacent wellhead.

If groundwater is encountered during the excavation of impacted soil, a groundwater sample will be collected for Table 915-1 organic and inorganic constituents in groundwater (Benzene, Toluene, Ethylbenzene, Total Xylenes (BTEX), naphthalene, 1,2,4-Trimethylbenzene, 1,3,5-Trimethylbenzene, Chloride ion, Sulfate ion and Total Dissolved Solids (TDS). Should no additional active remediation be required following source removal at the location, a no further action (NFA) determination will be requested within 90 days following laboratory confirmation of the removal of impacted soils with respect to the applicable Table 915-1 screening levels at the site.

If groundwater impacts are observed, an NFA will be requested once four consecutive quarters of groundwater sampling have been completed and reported at the location with concentrations of Table 915-1 constituents below regulatory limits. As needed, soil and/or groundwater remediation plans will be developed and submitted to ECMC in a supplemental Form 27.
