## INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A site investigation was conducted pursuant to ECMC Rule 911 at the WATSON T6N-R65W-S28 L02 Facility and Tank Battery location.

## PROPOSED SAMPLING PLAN

### Proposed Soil Sampling

Will soil samples be collected as part of this investigation? ( Number, type (grab/composite), analyses, and locations of samples ):

Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), at the risers for the flowline (s) and dumpline(s) of any separator(s). In addition, the on-site dump lines located between the separator and tank battery were removed by pulling from either end. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

### Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? ( Number, analyses, and locations of samples ):

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB by EPA Method 8260, chloride and sulfate anions by EPA Method 300.0, and total dissolved solids (TDS) by Method SM 2540C.

Visual inspection of the tank battery area occurred during abandonment activities. Field personnel field screened all disturbed areas using a PID, visual, and olfactory senses to determine if laboratory confirmation sampling was required. The ECMC Tank Battery and Produced Water Vessel Closure Checklists were utilized and filled out during the abandonment process. A photolog was attached.

Fifteen background soil samples were collected from an area not impacted by oil and gas development and at similar depths and lithologies as confirmation soil samples collected at the location and analyzed for Table 915-1 metals and SSR constituents. Background soil sample analytical results were reported with elevated levels of pH, Arsenic (As) and Barium (Ba).

Re-sampling efforts at the AST01-B 0.5 FT soil sample location—previously identified as exceeding criteria—indicated that the soil at this location is now unimpacted.

Supplemental decommissioning site investigation activities were conducted on November 6, 2024. During this investigation, confirmation soil samples were collected from the excavation areas associated with the produced water vessel(s), beneath the ground oil tank(s), and at the risers for the flowline(s) and dump line(s) connected to any separator(s). Laboratory analytical results confirmed that no impacts are present, and removal of additional soil is not required.

The material excavated during tank battery equipment removal activities was reused as backfill in the respective excavations.

**REMEDICATION SUMMARY**

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Provide a brief narrative description including: technical justification, schedule for implementation, estimated time to attain NFA status, plus plans and specifications for the selected remedial action technology.

Five background soil samples were collected from similar depths and lithologies as confirmation soil samples and will be used to characterize the native soil. Background soil sample analytical results will potentially attribute elevated metals and inorganics concentrations to native soil conditions. Background soil sample analytical results were reported with elevated levels of arsenic (As), barium (Ba), and pH. Confirmation sample concentrations of As and Ba are less than 125% of the maximum background concentration for samples collected at the same depths and are proposed to be attributed to native soil concentrations. Concentrations of pH observed in three of the five confirmation samples exceeds the maximum background concentration at complementary depths. The Operator proposes to resample the Pwv01B-4.0(2), Pwv01N-2.0(2) and Sep01FL-4.0(2) sample locations at the same depth where the initial elevated pH concentrations were observed. Noble will request an NFA be granted if the reanalyzed samples comply with the Table 915-1 concentration standard. Background samples will be used to justify elevated concentrations.

Alternatively, if the sample results exceed the Table 915-1 standards and cannot be attributed to native soil conditions via background soil characterization a minimum of five additional samples will be collected to delineate the magnitude and extent of elevated constituents. Following completion of the delineation, Noble will submit a detailed reclamation plan to address elevated SSR constituents that includes, but is not limited to, soil analysis from adjacent undisturbed lands,

The AST01-B 0.5FT sample location analysis was reported with an elevated concentration of Naphthalene and was out of the temperature preservation range when submitted to the laboratory on 6/11/24. The AST01-B 0.5FT soil sample location was resampled and analyzed for the full Table 915-1 suite to confirm the original results on 11/6/24. Impacts were not observed.
