Pursuant to CECMC Rule 911 a site investigation was conducted pertaining to the CHAMPLIN 78 AMOCO C wellhead cut and cap. The wellhead was cut and capped per Form 6 Doc #403584204. Additional confirmation samples were collected while the on-location flowline was being removed (Form 42 Doc#403754523). No additional samples have been collected since the previous Form 27 submittal. This Form is being submitted to meet quarterly reporting requirements. No new site investigation activities have occurred since the previous Form submittal. Request for closure is pending the removal of a third party's equipment.

The seed mix will be approved by the surface owner.

A third party's equipment was still present on-site at the time of the sampling events. Connections will be cut from meter sheds and the equipment will be removed in compliance with the 1000 series rules. If impacts are discovered, the Operator will determine if impacts were caused by equipment upstream or downstream of the equipment to determine the responsible party, regulatory jurisdiction, and reporting/cleanup requirements. If impacts are not present; the Operator will submit field screening and photo documentation only. POCO has attempted to get a timeline for when meter sheds will be removed from the facility by the third party. A follow-up email was sent on 3/3/2025 requesting a timeline for removal.
