**INITIAL ACTION SUMMARY**

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the WARDLAW 20-28 wellhead cut and cap. The wellhead was cut and capped per ECMC rules. The flowline was previously abandoned PRIOR to the 2018 Registration rules. The flowline is now planned for removal, and the ECMC will be updated in a supplemental Form 27 when a portion of the flowline is able to be removed. Soil samples will be taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway.

Will soil samples be collected as part of this investigation? ( Number, type (grab/composite), analyses, and locations of samples ):

Soil samples will be taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples were/will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All sample analysis was/will be performed by a certified laboratory using approved ECMC laboratory analysis methods.

If groundwater is encountered, a grab groundwater sample will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB, chloride and sulfate anions and total dissolved solids (TDS).

Six site specific background soil samples were collected from approximately 4 ft., and 6 ft-bgs from three soil borings (BKG01 to BKG03) in areas away from oil and gas infrastructure from similar depths and soil horizons as confirmation soil samples and were submitted for analysis of pH, EC, SAR, and total metals (Table 915-1 List) by ECMC approved methods. The highest background concentrations for EC is 7.36 mmhos/cm, and SAR 10.4 and the highest 1.25 maximum background concentrations for arsenic is 7.25 mg/kg and selenium is 0.463 mg/kg.

Noble plans to recollect confirmation soil samples WH01@6 to determine if the barium results are anomalous. This is expected to be completed by the end of the first quarter of 2026.

Additional flowline decommissioning activities will be completed by another Chevron business partner and will be summarized in a subsequent Supplemental Form 27 submittal.

Pursuant to Rule 913.e, quarterly reporting will continue for the location until data indicates no further action is warranted.
