INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was proposed in Form 27 #403371312 pertaining to the PLUSS G25-07 (25-2) wellhead cut and cap and flowline removal. Approximately 2772' of flowline was proposed to be removed, however a portion of the flowline was abandoned-in-place due to field constraints. The wellhead was cut and capped per ECMC rules. A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples were collected and field screened at the N-E-S-W sides of the wellhead. Soil samples were taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples were analyzed by a certified laboratory for organic compounds in soil per ECMC Table 915-1 compounds. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.
