INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A site investigation will be conducted pursuant to ECMC rule 911 at the CPR Miller 21-27 Tank Battery (489364) oil and gas location pertaining to the decommission of equipment and on-location lines operated by Crestone Peak Resources. See site map exhibit for details. Crestone Peak resources will not remove any of the equipment or conduct any investigation related to the equipment operated by KP Kauffman at Jillson Battery 1-6 (476479) which shares the same area of disturbance as the CPR Miller 21-27 Tank Battery (489364) oil and gas location.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Grab confirmation soil samples will be collected from beneath the above ground oil tank, water vault, separator, and flowline start/end points. Potholes will be dug every 250 feet along the flowline path. These observation points will be photographed and field screened. Additional soil samples will be collected when flowline repairs are observed, changes in flow direction, or when there is a change in the flowline material type. A grab confirmation soil sample will be collected from the center of the produced water vault footprint, or areas of observed impact based on visual and olfactory observation. A minimum of four sidewalls and the base will be field screened. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis method
