INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the Howell C32-12 wellhead cut and cap. Wellhead decommissioning activities and confirmation soil sampling at the Howell C32-12 wellhead occurred on October 10, 2024. Please refer to the operator comments for additional information regarding the historical release and remedial efforts to be conducted at the wellhead.

The flowline was previously abandoned on 7/23/2018, and the ECMC was notified on Form 44 Document number 402060535.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample was collected from the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Following source mass removal of hydrocarbon impacted soil, confirmation soil samples will be collected from the final extents of the excavation. Soil samples will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

If groundwater is encountered, a grab groundwater will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB by EPA Method 8260, chloride and sulfate anions by EPA Method 300.0, and total dissolved solids (TDS) by Method SM 2540C.

Visual inspection of the wellhead area occurred during abandonment activities. Wellhead decommissioning activities and confirmation soil sampling at the Howell C32-12 wellhead occurred on October 10, 2024. Laboratory analytical results indicated a historical release occurred at the Howell C32-12 decommissioned wellhead and was reported as a historic release in Form 19 document number 403954962. Hydrocarbon impacted material at the wellhead will be removed and hauled to a permitted disposal facility. Final analytical results will be summarized in a subsequent Supplemental Form 27 submittal and will be reported along with ongoing Remediation Project Number 37163.

OPERATOR COMMENT

This Supplemental Form 27 was prepared as a second quarter 2025 timeline update for the historical release that was discovered at the former Howell C32-12 wellhead.

Excavation activities are tentatively scheduled to commence on April 28, 2025. In accordance with the COA listed in the approved Supplemental Form 27 Document Number 403954778, the implementation schedule has been updated to reflect these dates. Supplemental source mass removal activities will be initiated via mechanical excavation. Following source mass removal of hydrocarbon impacted soil, confirmation soil samples will be collected from the final extents of the excavation. Soil samples will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Pursuant to Rule 913.e, quarterly reporting will continue for the location until data indicates no further action is warranted.
