**INITIAL ACTION SUMMARY**

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911, a site investigation was conducted pertaining to the Village 16A-DU wellhead cut and cap and flowline removal. The wellhead was cut and capped per ECMC rules on 06/18/24. A grab soil sample (WH01 @ 6') was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, grab soil samples (WHS01-N @ 0-6", WH01-E @ 5', WH01-S @ 5', WHS01-W @ 0-6") were field screened at the N-E-S-W sides of the wellhead. Approximately 134' of flowline was removed on 05/28/24 per Form 44 # 403878773. A laboratory soil sample was collected from beneath the flowline riser at the wellhead (FLR01-W @ 3') and separator (FL01R-S @ 5').

**PROPOSED SAMPLING PLAN**

**Proposed Soil Sampling**

Will soil samples be collected as part of this investigation? ( Number, type (grab/composite), analyses, and locations of samples ):

Sampling was conducted as described in the Initial Action Summary of this Form 27. A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were taken at the flowline start and end points, as well as at the midpoint of the flowline. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling was required. Two background soil samples were collected from one discrete location (BKG01) up-gradient of the former wellhead location and analyzed for metals in soil per ECMC Table 915-1, pH, SAR, and EC. Background soil samples were collected from depths of 3 and 5 feet below ground surface (ft bgs). The maximum background concentration for pH was observed to be 9.02. The maximum background concentrations with a 1.25x multiplier applied for arsenic, barium, and lead were calculated to be 7.24 mg/kg, 153 mg/kg, and 11.5 mg/kg, respectively. All pH, arsenic, and barium concentrations observed during decommissioning were below background levels.
