INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911, site investigations were conducted pertaining to the OCOMA C17-15 wellhead cut and cap and flowline removal. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Approximately 2006' of flowline was removed, however a portion of the flowline was abandoned-in-place due to field constraints. So as to not disturb the area of field constraint, soil samples were taken at the start and endpoint of the flowline where the area exists and one soil sample was taken along the flowline at the direction change where the flowline was removed. The ECMC was notified in the Form 44 Document Number 404127831.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

The confirmation soil samples collected during wellhead cut and cap activities were determined to be outside of the required temperature preservation range when delivered to the laboratory. Re-sampling was conducted. Soil samples were taken along the flowline at points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. Background soil samples will be analyzed for analysis of metals per ECMC Table 915-1 and soil suitability parameters including pH, EC, SAR, and boron. All sample analysis will be performed by a certified laboratory using approved ECMC laboratory analysis methods.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

If groundwater is encountered, a grab groundwater sample will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB, chloride and sulfate anions and total dissolved solids (TDS).

Visual inspection of the wellhead and flowline areas occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling was required. The ECMC Closure Checklists were utilized and filled out during the abandonment process.

Five site specific background soil samples collected from approximately 2 ft-bgs from five soil borings (BKG1 to BKG5) were submitted for analysis of pH, EC, SAR, and total metals (Table 915-1 List) by ECMC approved methods. Additional background soil sampling will be conducted in areas away from oil and gas infrastructure and samples will be collected from similar depths and soil horizons as confirmation soil samples to further investigate residual inorganic concentrations in soil at the site. Background soil samples will be analyzed by a certified laboratory for analysis of metals per ECMC Table 915-1 and soil suitability parameters including pH, EC, SAR, and boron.

The implementation schedule has been changed due to the necessity for supplemental site investigation activities adjacent to the wellhead and the flowline.

OPERATOR COMMENT

This form is being submitted as a third quarter timeline update for the Ocoma C17-15 wellhead and flowline.

Facility closure activities and confirmation soil sampling were conducted at the wellhead and flowline on May 20, and September 10, 2024, and were summarized in Supplemental Form 27 Document Numbers 403916560 and 404225225, respectively. The ECMC was notified of flowline abandonment in Form 44 #404127831.

The confirmation soil samples collected during wellhead cut and cap activities were determined to be outside of the required temperature preservation range when delivered to the laboratory. Re-sampling was conducted. Analytical results are pending review and will be summarized in the next quarterly Supplemental Form 27 submittal.

Noble proposes to conduct additional background soil sampling from boring locations at similar depths and soil horizons as confirmation soil samples, in areas away from oil and gas infrastructure to further investigate residual inorganic concentrations in soil at the wellhead.

Pursuant to Rule 913.e, quarterly reporting will continue for the location until data indicates no further action is warranted.
