INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to COGCC Rule 911 a site investigation will be conducted pertaining to the SITZMAN 27-08 wellhead cut and cap and flowline removal. Approximately 182' of flowline will be removed, however a portion of the flowline will be abandoned-in-place due to field constraints. The COGCC will be updated in a supplemental Form 27. The wellhead will be cut and capped per COGCC rules. Additionally, soil samples will be collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample will be collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples will be collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. A grab confirmation soil sample will be collected at the wellhead excavation. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

This 4Q2025 quarterly update for the SF27 for SITZMAN 27-8 (REM 26855) is being submitted to serve as a timeline update.

The Operator acknowledges that the previous approved form (#404273041) was submitted on 07/17/25 and is in process with ECMC. Confirmation and delineation soil sampling will be conducted by collecting one (1) soil sample at the former wellhead and four (4) soil samples in the NE-S-W directions. Two (2) soil samples will be collected at both ends of the flowline. All soil samples will be analyzed by a certified laboratory for ECMC Table915-1 soil compounds using approved ECMC laboratory analysis methods. Three (3) background soil samples will also be collected and analyzed by a certified laboratory for ECMC Table 915-1 SSR and metals. Operator notes that land owner has requested site access be delayed until winter.

Pursuant to Rule 913.e, quarterly reporting will continue for the location until data indicates no further action is warranted.
