A site investigation was conducted pursuant to ECMC Rule 911 at the ORR STATE 36 SEC Facility around the area of the Partially Buried Vessel being removed.

Grab confirmation soil sample were collected from the partially buried vessel excavation. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB by EPA Method 8260, chloride and sulfate anions by EPA Method 300.0, and total dissolved solids (TDS) by Method SM 2540C.

All soil impacted with organic compounds above ECMC Table 915-1 protection of groundwater soil screening levels (GSSLs) were successfully removed through the remedial excavation completed on January 10, 2025 and January 14, 2025. Based on an evaluation of confirmation soil sampling results, elevated arsenic, barium, and lead are present in the sidewalls and base of the excavation above ECMC Table 915-1 GSSLs.
