A site investigation was conducted pursuant to ECMC Rule 911 at the KISSLER T4N-R64W-S23 L02 Tank Battery location.

Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the separator(s). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

Groundwater was encountered during site investigation activities on 11/2/2023. A sample was collected and analyzed for all organic compounds per ECMC Table 915-1. If groundwater is encountered during any further site investigation activities a grab groundwater sample will be collected and analyzed for all organic compounds and inorganic parameters per ECMC Table 915-1.

The organic compound exceedances observed at sample location PWVB01@6.5' will be removed through a remedial excavation. Remedial excavation confirmation soil samples will be collected and analyzed for full ECMC Table 915-1 constituents.

REMEDICATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Provide a brief narrative description including: technical justification, schedule for implementation, estimated time to attain NFA status, plus plans and specifications for the selected remedial action technology.

Laboratory analytical results indicated a historical release had occurred at the location of soil sample PWVB01@6.5' and was reported as a historic release in Form 19 document number 403352064. A site investigation was completed on 11/02/2023. Eight soil samples and one groundwater sample was collected to define the magnitude and extent of soil impacts at the location. Groundwater impacts were not observed. The source will be excavated and confirmation soil samples will be collected and analyzed for the full Table 915-1 suite of analytes. The proposed excavation extent measures 60'x60'x12' deep and is illustrated on the attached remedial action plan via document number 404116087.

Background soil samples will be collected from areas not impacted by oil and gas activities concurrent with the excavation activities to evaluate the native soil conditions.

If groundwater is encountered during the excavation of impacted soil, a groundwater sample will be collected for Table 915-1 organic and inorganic constituents in groundwater (Benzene, Toluene, Ethylbenzene, Total Xylenes (BTEX), naphthalene, 1,2,4-Trimethylbenzene, 1,3,5-Trimethylbenzene, Chloride ion, Sulfate ion and Total Dissolved Solids (TDS). Should no additional active remediation be required following source removal at the location, a no further action (NFA) determination will be requested within 90 days following laboratory confirmation of the removal of impacted soils with respect to the applicable Table 915-1 screening levels at the site.

If groundwater impacts are observed, an NFA will be requested once four consecutive quarters of groundwater sampling have been completed and reported at the location with concentrations of Table 915-1 constituents below regulatory limits. As needed, soil and/or groundwater remediation plans will be developed and submitted to ECMC in a supplemental Form 27.

Groundwater was encountered during site investigation activities on 11/2/2023 while defining the magnitude and extent of impacts at the PWVB01@6.5' sample location. A sample was collected and analyzed for all organic compounds per ECMC Table 915-1. Groundwater impacts were not observed. The operator will be returning to the site before remedial excavation activities begin commencement and groundwater will be re-sampled and analyzed for all organic compounds and inorganic parameters per ECMC Table 915-1 to confirm the absence of any organic exceedances and acquire inorganic data. Further still, if groundwater is encountered during excavation activities a grab sample will be collected and analyzed for all organic compounds and inorganic parameters per ECMC Table 915-1.
