INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the BORN-SITZMAN 05 wellhead cut and cap and flowline removal. Approximately 3045' of flowline was removed. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were taken along the flowline any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. The Field Qualitative Criteria Checklist was utilized during decommissioning activities and no visual and olfactory impacts were observed. Based on laboratory analytical data for the FOOS C 27-22 flowline (REM 26851), historical releases were reported on May 1, 2025, under F19 Document Numbers 404186008 and 404186017, where duplicate BORN SITZMAN 5 flowline samples were collected from common trench potholes with elevated naphthalene and benzo(a)anthracene at sample locations FL02-03 and FL02-04, respectively.

The confirmation soil samples collected during wellhead cut and cap activities were determined to be outside of the required temperature preservation range when delivered to the laboratory. Re-sampling will be conducted. Soil samples were taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples were and will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were and will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Proposed Groundwater Sampling

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic compounds per ECMC Table 915-1 and inorganic parameters (TDS, chloride, sulfate, sodium, potassium, bicarbonate, and carbonate (as CaCO₃)).

Visual inspection of the wellhead and flowline areas occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling was required. The ECMC Flowline Closure and Wellhead Closure Checklists were utilized and filled out during the abandonment process. A detailed summary of flowline decommissioning activities, including field notes, site photos, figures, and laboratory analytical results, is attached to this Form 27.

Background soil samples will be analyzed by a certified laboratory for analysis of metals per ECMC Table 915-1 and soil suitability parameters including pH, EC, SAR, and boron. The background soil sample locations are shown on the attached proposed excavation map and will be reported in a subsequent supplemental Form 27.

The naphthalene and benzo(a)anthracene exceedances observed at sample locations (FL02-03 and FL02-04) on May 7, 2-25 will be removed through a remedial excavation in accordance with the proposed excavation map attached to this Form 27. Soil samples will be collected from the base and sidewalls of the respective final excavation extents and will be submitted for analysis of the full ECMC Table 915-1 suite.

The implementation schedule has been changed due to the decommissioning of the BORN SITZMAN flowline and necessity for remedial excavation activities adjacent to the flowline. The proposed remedial excavation will be completed following the approval of this form.

OPERATOR COMMENT

This Form 27 is being submitted to include a 2Q 2025 update for the BORN-SITZMAN 5 wellhead and flowline (REM #32829) and the decommissioning results and historic reportable release discovered at the former BORN-SITZMAN 5 flowline. A proposal to excavate the naphthalene and benzo (a)anthracene exceedances identified during decommissioning (soil samples FL02-03@3' and FL02-04@3') is presented in the Remedial Action Plan section of this Form 27. Based on laboratory analytical data received on 4/29/2025 historic releases were reported for sample locations FL02-03@3' and FL02-04@3' under Form 19 Document Numbers 404186008 and 404186017, respectively.

Background samples were collected on May 14, 2025 to determine site specific background concentrations. Final analytical results are pending and will be reported in a subsequent supplemental Form 27.

Facility closure activities and confirmation soil sampling were conducted at the wellhead on June 7, 2024, and were summarized in Supplemental Form 27 Document #403882656. The confirmation soil samples collected during wellhead cut and cap activities were determined to be outside of the required temperature preservation range when delivered to the laboratory. Re-sampling will be conducted concurrently with the remedial excavation that is proposed in the Remedial Action Plan section of this Form 27.

Pursuant to Rule 913.e, quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The results of the supplemental site investigation will be submitted on a subsequent Form 27.
