INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A site investigation was conducted pursuant to ECMC Rule 911 at the TREBOR T5N-R64W-S12 L03 (Trebtor B12-03, 04) Facility and Tank Battery location.

On 10/09/2024, the tank battery was decommissioned in accordance with ECMC rules. Laboratory soil samples were collected from the partially-buried produced water vessel excavation (PWV01-B@3') and field screening samples were taken from the N, E, S, & W sidewalls (PWV01-N@2' through PWV01-W@2'). The screening sample with the highest PID (PWV01-E@2') was collected for laboratory analysis from the E sidewall. Lab samples were also collected beneath the above ground storage tank (AST01@0-6") and beneath the the separator risers for the dumpline (SEP01-DL@3') and the flowline (SEP01-FL@3'). Additionally, field screening samples were collected beneath the flares (FLARE01@0-6" and FLARE02@0-6").

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Soils were collected as described in the Initial Action Summary of this Supplemental Form 27. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, metals in soil per ECMC Table 915-1, pH, EC, SAR, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Visual inspection at the tank battery area occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling was required. Four background soil samples were collected from one discrete location (BKG01) near the tank battery and analyzed for metals in soil per ECMC Table 915-1, pH, EC, SAR and boron. Background soil samples were collected from depths ranging between 0.5 to 4 feet below ground surface (ft bgs). The maximum background concentration for pH was observed to be 8.47. The maximum background concentrations with a 1.25x multiplier applied for arsenic and barium were calculated to be 2.46 mg/kg and 221 mg/kg, respectively. All arsenic and barium concentrations observed during decommissioning were below background levels.

A supplemental site investigation (SSI) will be completed to vertically and horizontally delineate the pH exceedances observed during decommissioning. A proposed soil boring location maps are attached to this Form 27. During the SSI, soil samples will be collected and analyzed for full ECMC Table 915-1 constituents. Concurrently with the SSI, additional background samples will be collected to determine if pH concentrations are attributed to native soil conditions at the site. The SSI will be completed in accordance with the proposed implementation schedule, and the results of the SSI will be submitted on a subsequent Form 27.

Concurrently with the SSI, additional background samples will be collected to determine if elevated pH concentrations are attributed to native soil conditions at the site. A proposed SSI map is attached to this Form 27. The SSI will be completed in accordance with the attached proposed site investigation map, and proposed sampling plan outlined in the Site Investigation Report section of this Form 27.
