Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

One soil sample was reported with a low value for Table 915 inorganic constituents for pH (AST01@6"). A confirmation soil sample will be collected from the low pH soil sample location to validate the original results and/or delineation soil samples will be collected to define the extent of inorganic impacts. If the low pH value sample location is delineated, a reclamation plan will be prepared to address the low pH soil. As needed, soil and/or groundwater remediation plans will be developed and submitted to ECOM in a supplemental Form 27.

Additionally soil will be resampled and analyzed for the full Table 915-1 suite of analytes at all previously submitted sample locations from the 3/2/2023 decommissioning event (AST01@6.0", SEP01@4', PWVW01@5.5', PWVB01@7") at the same depths where the initial sample were collected in order to confirm the initial sample/re-sample results and acquire metal concentration data. Additional background samples will be collected to characterize native soil conditions. Noble will request an NFA be granted if the reanalyzed samples comply with the Table 915-1 concentration standard. Background samples will be used to justify elevated concentrations.

This Form 27 is being submitted as a Q1 2025 timeline update for the former LEONARD T4N-R64W-S21 L01 tank battery location and to propose an additional supplemental site investigation.

The operator completed the additional pH site investigation sampling as outlined in this proposed Site Investigation Report workplan prior to the Proposed completion of site investigation date detailed in the Implementation schedule on 12/12/2024. Lab data has not yet been received from the lab but will be reviewed and compiled into a report which will be submitted on the next form submittal.

The operator will conduct a additional supplemental site investigation collecting resamples at all previously submitted sample locations from the 3/2/2023 decommissioning event (AST01@6.0", SEP01@4', PWVW01@5.5', PWVB01@7') to confirm the initial sample/re-sample results and acquire metal concentration data. Additional background samples will be collected to characterize native soil conditions. Please refer to the site investigation as outlined in this proposed Site Investigation Report workplan. The Operator will complete the additional site investigation activities as outlined in the proposed Site Investigation Report workplan following the approval of this form.

Quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The results of the supplemental site investigation will be submitted on a subsequent Form 27.
