A site investigation was conducted pursuant to ECMC Rule 911 at the GUSTAFSON T6N-R65W-S4 L01 Facility and Tank Battery location.

Grab confirmation soil samples will be collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the risers for the flowline(s) and dumphine(s) of any separator(s). Soil samples will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Fifteen background soil samples were collected from an area not impacted by oil and gas development and at similar depths (0.5', 2', and 4') and lithologies as confirmation soil samples collected at the location and analyzed for Table 915-1 metals and SSR constituents. Background soil sample analytical results were reported with elevated levels of arsenic, barium, lead, and pH.
