INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A site investigation was conducted pursuant to ECMC Rule 911 at the HANSCOME T4N-R64W-S28 L03 Facility and Tank Battery location.

On 6/27/2024, a soil sample was collected along the flowline beneath the northern separator riser (FL01R-S@2') and analyzed for full ECMC Table 915-1 contaminants of concern during decommissioning of the associated HANSCOME C28-29D Flowline (Remediation #34734). This sample was reported under ECMC Document #403856413.

On 12/18/2024, a soil sample was collected along the flowline beneath the southern separator riser (FL01R-SEP@4') and analyzed for full ECMC Table 915-1 contaminants of concern during decommissioning of the associated HANSCOME C28-21 Flowline (Remediation #36308). This sample was reported under ECMC Document #404033740.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Grab confirmation soil samples were collected from the produced water vessel(s) excavations, beneath the ground oil tank(s), at the risers for the flowline (s) and dumpline(s) of any separator(s). In addition, the on-site dump lines located between the separator and tank battery were removed by pulling from either end. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Additional Investigative Actions

Additional alternative investigative actions described in attached Site Investigation Plan (summary):

Visual inspection at the tank battery area occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses. Additionally, discrete soil samples were collected from the base of the excavation and excavation sidewall in areas most likely to be impacted and exhibiting the highest field screened VOC concentration. A detailed summary of tank battery decommissioning activities, including field notes, site photos, figures, and laboratory analytical results, is attached to previous Form 27 #404160815.

On 01/14/2025, three background soil samples were collected from one discrete location (BKG01) adjacent to the tank battery and analyzed for metals in soil per ECMC Table 915-1, pH, SAR, EC, and boron. Background soil samples were collected from depths ranging between 0.5 to 3 feet below ground surface (ft bgs). The maximum background concentration for pH was observed to be 9.03. The maximum background concentrations with a 1.25x multiplier applied for arsenic was calculated to be 3.61 mg/kg. All pH concentrations observed during decommissioning were below the maximum background level. All arsenic concentrations observed during decommissioning were below 1.25x the maximum background level.

Decommissioning analytical results indicated that organic compound concentrations were in compliance with the applicable ECMC regulatory standards in all soil sample locations. The pH concentrations above the ECMC Table 915-1 Soil Suitability Limits observed at soil sample locations AST01@0-6" and PWV01-B@3' were below the maximum background concentration of 9.03. Arsenic concentrations in excess of the ECMC Table 915-1 regulatory limits were under 1.25x the maximum background concentration. No other inorganic compound or metal exceedances were identified. Groundwater was not encountered during decommissioning activities. Based on the analytical results from decommissioning, no further investigation is required at this time.
