INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the WATSON 66N65W 28SWNW Tank Battery removal. Soil samples were collected from the base of the produced water vessel excavation, beneath the ground oil tank, and at the risers for the flowline and dumpline separator.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Grab confirmation soil samples were collected from the base of the produced water vessel excavation, beneath the ground oil tank, and at the risers for the flowline and dumpline separator. In addition, the on-site dump lines located between the separator and tank battery were removed by pulling from either end. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1.

Additional Investigative Actions

Additional alternative investigative actions described in attached Site Investigation Plan (summary):

Visual inspection at the tank battery area occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses. Additionally, discrete soil samples were collected from the base of the excavation and excavation sidewall in areas most likely to be impacted and exhibiting the highest field screened VOC concentration. A detailed summary of decommissioning activities, including field notes, site photos, figures, and laboratory analytical results, were attached to the previous Supplemental Form 27 Document #403962533.

On September 20, 2024, three (3) background soil samples were collected from one (1) borehole (BKG01) near the tank battery at depths ranging between 0-0.5 and 5 feet below ground surface (ft bgs) and analyzed for metals in soil per ECMC Table 915-1, pH, SAR, EC, and boron. The maximum background concentration value for pH was observed at 8.40. The maximum background concentrations with a 1.25x multiplier applied for arsenic and barium were calculated to be 7.43 mg/kg and 226 mg/kg, respectively. All arsenic and barium concentrations observed during decommissioning were below 1.25x the maximum background levels.

This form has been submitted to provide the 4Q 2025 update for the WATSON-66N65W 28SWNW Facility and Tank Battery (REM #33995). Remediation and site investigation is now under the direction of Montrose Environmental (Montrose). The 3Q 2025 update (Doc. #404302645), including an update on the approved work plan proposed in the previous Form 27 (Doc. #403962533; approved on 12/19/2024), remains "In-Process" in Webforms. No work has been completed since the previous quarterly update.

A supplemental site investigation (SSI) will be completed to vertically and horizontally delineate the pH exceedances identified at sample locations AST01@0-0.5', PWV01-B@5', PWV01-E@3', SEP01-DL@3', and SEP01-FL@3'; soil samples collected will be submitted for full ECMC Table 915-1. Concurrently with the SSI, additional background samples (5+) will be collected and analyzed for metals and inorganics in soil per ECMC Table 915-1 to determine if elevated pH (AST01@0-0.5', PWV01-B@5', PWV01-E@3', SEP01-DL@3', and SEP01-FL@3') is attributed to native soil conditions at the site.
