Per the COA on document number 403955089 the Operator will establish soil suitability for reclamation parameters in background samples. Background samples will be collected in five locations from an area not impacted by oil and gas development at similar depths (3' and 5') and lithologies as confirmation samples collected at the location and analyzed for ECMC Table 915-1 metals and soil suitability for reclamation standards (SSR) (pH, EC, SAR, and Boron). The samples will be used to characterize native soil and potentially attribute elevated metals and inorganics concentrations to native soil conditions.

The Operator will provide additional characterization of the magnitude and extent of electrical conductivity (EC) impacts on the site. The Operator will also resample locations (SS-1, SS-2, SS-3, SS-4, SS-5, SS-6, SS-8, and SS-9) with previously documented soil suitability exceedances and analyze those samples for Table 915-1 Contaminants of Concern.

SOURCE REMOVAL SUMMARY

Organic soil impacts were not discovered during the SHABLE USX AB 11-04P produced water vault decommissioning. Based on decommissioning site investigation activities and laboratory analytical results of confirmation soil samples collected from the produced water vessel excavation removal of soil is not needed. The material excavated during produced water vault removal activities was used as backfill for the excavations.

The initial NFA request was removed and additional site investigation is needed to define the magnitude and extent of EC, resample previously documented soil suitability exceedances and analyze those samples for Table 915-1 Contaminants of Concern.

OPERATOR COMMENT

This form serves to comply with the Rule 913.e. reporting schedule. The review status of the previously proposed workplans (Doc. # 404050817 and 404160023) are "In Process" on Web Forms. Pending ECMC EPS form review/approval, the Operator will complete the additional site investigation and remediation as outlined on Doc. #s 404050817, 404160023, and this F27. Supplemental Form 27s will be prepared and submitted on a quarterly schedule to provide updates and progress of the remediation until closure criteria has been achieved.

Additional site investigation was conducted to address elevated EC and a report detailing the investigation was attached to document number 402640641. Elevated EC was observed in multiple characterization samples used to delineate the magnitude and extent of elevated EC but was not deemed attributable to native soil conditions by the ECMC. Per the COA provided on document number 402640641 the Operator submitted a detailed reclamation plan pursuant to Rule 915.b and requested NFA designation be granted with elevated inorganics left in situ. The NFA request was denied on document number 403955089.

This Form 27 serves to comply with the Rule 913.e. reporting schedule and is being submitted to propose additional site investigation activities at the former Shable USX AB 11-04P tank battery.

Due to the age of the documents secured versions could not be generated by the laboratory because the lab does not have access to reports generated before January 2021. The "2009266 - Noble - Shable USX AB 11-04P" and "2011172 - Noble - Shable USX AB 11-04P" reports have been submitted previously on approved document # 402640641 and are attached to document number 404050817.
