This form serves as notification for the decommissioning of the Arapahoe Unit 155 (32-21) wellhead. The ground and subsurface shall be inspected for hydrocarbon impacts during equipment removal. At a minimum, soil sampling shall be conducted in the proposed locations discussed below and shown on the attached proposed soil sample location map.

### Proposed Soil Sampling

One (1) discrete grab soil sample will be collected as shown in the proposed sample location diagram, adjacent to the capped well casing. Four (4) field screening surface soil samples be collected in each cardinal direction surrounding the wellhead and one (1) background sample will be collected from an adjacent, upgradient location. The grab sample will be utilized for full Table 915-1 listed constituents. The background sample will be analyzed for EC, SAR, pH, boron, and metals.

### Proposed Groundwater Sampling

Should groundwater be encountered, a sample will be collected as soon as practical and shall be submitted for laboratory analysis of Table 915-1 Inorganic Parameters and Organic Compounds in Groundwater.

This form serves as the 2Q2025 quarterly update for this location. Citation has developed a tracking system for quarterly reporting compliance but due to limited resources was unable to keep up with quarterly reports for this project. Citation has addressed the situation by acquiring additional resources needed to maintain compliance moving forward.

The schedule for decommissioning this location was delayed but work was completed in 3Q2025. A flowline riser was observed near the wellhead during plugging and abandonment activities. Further investigation of on and/or off-site flowlines is ongoing. Decommission and investigation activities will be reported on the Form 27 Supplemental Report for 3Q3025.
