Operator submitted a Final Reclamation Complete Notice on 9/22/2016.

A portion of the northern Land Application Site (LAS) is no longer incorporated into crop production. It appears the surface owner converted from flood irrigation to pivot irrigation, which resulted in the northern LAS area being outside of the pivot irrigation.

Based on historical aerial imagery, other areas of the LAS appear to be uniform with the surrounding reference crop areas and do not appear to indicate any unrestored subsidence. Refer to the attached photos.
