Historic Form 19 (2009): Contract crew employee was draining filtered produced water from a 4" poly line between Pond 4 and the 697-09-61 pad. The line was being drained to prevent damage due to freezing. The contract employee opened the valves and over-flowed the frac tank, due to an error in the strapping of the tank. All the filtered produced water was contained on the pad. Valves were closed and a water truck was mobilized to removed free fluids (10bbls recovered).
