 While there, I observed normal operations. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife black bear Management and Density habitat.
 Last Inspection document # 707801055 C/A's have not been completed therefore all C/A dates remain.
 During this inspection the following possible compliance issues were observed:

1. No evidence of any storm water controls to prevent sediment migration or tracking BMP's to prevent sediment from location being transported from location. C/A date 9/9/2024
2. Well head signage has faded information and is illegible.
3. 3 dead men are not marked properly.
