A site investigation was conducted pursuant to ECMC Rule 911 at the JEPSSEN T3N-R65W-S2 L04 Facility and Tank Battery location.

Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), at the risers for the flowline (s) and dumpline(s) of any separator(s). In addition, the on-site dump lines located between the separator and tank battery was removed by pulling from either end. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

During Site Investigation activities on 07/31/2025, twenty background soil samples were collected from five discrete locations (BKG03-BKG07) adjacent to the tank battery and analyzed for metals in soil per ECMC Table 915-1, pH, SAR, EC, and boron. Background soil samples were collected from depths ranging between 3 to 10 feet below ground surface (ft bgs). The maximum background concentration for pH, was observed to be 8.01. The maximum background concentration with a 1.25x multiplier applied for arsenic was calculated to be 2.8 mg/kg. All arsenic concentrations observed during SSI activities were below 1.25x the maximum background level.

BH02-BH05 were advanced surrounding BH01 to vertically and laterally delineate impacts identified at PWV01-B@4' and PWV01-N@2.5'. Soil samples were collected and analyzed for full ECMC Table 915-1 constituents. Groundwater was not encountered during this assessment. Analytical results indicated that all organic and inorganic compounds were in compliance with the applicable regulatory standards.

The implementation schedule has been updated to reflect the completion of the July 2025 site investigation at the Jepsen T3N-R65W-S2 L04 tank battery, and necessity for remedial excavation activities adjacent to the tank battery. The proposed remedial excavation will be completed following approval of this form.

OPERATOR COMMENT

This Form 27 is being submitted to include the supplemental site investigation (SSI) results for the Jepsen T3N-R65W-S2 L04 Tank Battery (Rem # 37609) location. A comprehensive data packet summarizing the SSI activities is attached to this Form 27, and a detailed summary of the previously completed SSI activities is presented in the Remedial Action Plan sections and below.

A Site Assessment was conducted on 7/31/2025 to delineate impacted media, during which five soil borings were advanced to depths ranging from 0 to 6 ft. bgs. BH01 was advanced at the same location as soil samples PWV01-B@4' and PWV01-N@2.5' to vertically delineate impacts at that location. BH02-BH05 were advanced surrounding BH01 to vertically and laterally delineate impacts identified at PWV01-B@4' and PWV01-N@2.5'. Soil samples were collected and analyzed for full ECMC Table 915-1 constituents. Groundwater was not encountered during this assessment. Analytical results indicated that all organic and inorganic compounds were in compliance with the applicable regulatory standards.

During Site Investigation activities on 07/31/2025, twenty background soil samples were collected from five discrete locations (BKG03-BKG07) adjacent to the tank battery and analyzed for metals in soil per ECMC Table 915-1, pH, SAR, EC, and boron. Based on decommissioning and site investigation analytical results, remedial excavations will be conducted to remove the sources identified at soil sample locations PWV01-B@4', PWV01-N@2.5', and AST01@0-6". Soil samples will be collected from the base and sidewalls of the final excavation extent and submitted for laboratory analysis of the full ECMC Table 915-1 suite. Concurrently with the remedial excavations, additional background soil samples will be collected to determine if pH is attributed to native soil conditions at the site.

Pursuant to Rule 913.e, quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The results of the supplemental site investigation will be submitted on a subsequent Form 27.
