Conduct reclamation on the location/road in accordance with 1004 rules including, but not limited to: removal of signage/debris, removal of gravel, compaction alleviation, recontour/regrade and establish vegetation with total perennial, non-invasive uniform plant cover of at least 80% of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local soil conservation district.

Comply with Rule 1002.f and ensure erosion controls are implemented to stabilize the seeded soil.

Comply with Rules 1004.e and 606.c: Oil and Gas Locations will be kept free of all Undesirable Plant Species.

<p><b>RECLAMATION COMMENTS:</b> Pursuant to Form 6(s) #403143653 well API #05-081-07692 was plugged and abandoned on 07/12/2022. Form 4 #403816952 stating final reclamation complete was received by ECMC on 06/06/2024.</p> <p>The location is composed of crested wheatgrass, intermediate wheatgrass and smooth brome. Small amounts of prickly Russian thistle, a weedy annual species, were observed throughout the location. Scotch thistle, a List B noxious weed, is present in high amounts throughout the location. Scotch thistle basal rosettes and new growth were observed throughout the entirety location and in dense amounts on the eastern portion of the location. It does not appear as though weeds have been managed recently. The site is at-risk of being overtaken by Scotch thistle. It is noted that species planted within the non-cropland area do not reflect species within the adjacent undisturbed reference areas, or vegetation that existed pre-disturbance.</p> <p>Debris remains scattered throughout the location. Old signage with incorrect Operator information, damaged rock socks, old piping, rebar and concrete barriers are present and require removal.</p> <p>Erosion and rilling is occurring on the northern end of the location.</p> <p>The access road on the southern end of the location that connects to a utility ROW has not been reclaimed. Reclamation work including removal of gravel, compaction alleviation and revegetation has not been performed along this portion of the access road and Location entrance.</p> <p>Pursuant to Rule 1004.a, all debris, abandoned gathering line risers and flowline risers, and surface equipment shall be removed within three (3) months of plugging a well. All access roads to plugged and abandoned wells and associated production facilities shall be closed, graded and recontoured. Well locations, access roads and associated facilities shall be reclaimed. As applicable, compaction alleviation, restoration, and revegetation of well sites, associated production facilities, and access roads shall be performed to the same standards as established for interim reclamation under Rule 1003. All other equipment, supplies, weeds, rubbish, and other waste material shall be removed. All such reclamation work shall be completed within twelve (12) months on non-crop land after plugging a well or final closure of associated production facilities.</p>	gaaschee	11/07/2025
