INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This form serves as notification of proposed soil sampling and investigation related to the decommissioned Arapahoe Unit 121 (23-32) wellhead. The ground and subsurface at the former surface location of the wellhead shall be inspected for hydrocarbon impacts. At a minimum, soil sampling shall be conducted in the proposed locations discussed below and shown on the attached proposed soil sample location maps and visual investigation areas.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Three (3) discrete soil grab samples will be collected as shown in the proposed sample location diagram: one (1) adjacent to the capped well casing/wellhead, one (1) adjacent to the wellhead flowline riser, and one (1) from where the flowline riser enters the facility. Four (4) field screening surface soil samples will be collected in each cardinal direction surrounding the former wellhead and facility riser and field screened with a photo-ionization detector (PID). At least one (1) background sample will be collected from an adjacent, upgradient location. The grab samples will be analyzed for full Table 915-1 listed constituents. The background sample will be analyzed for EC, SAR, pH, boron, and metals.

Should groundwater be encountered, a sample will be collected as soon as practical and shall be submitted for laboratory analysis of Table 915-1 Inorganic Parameters and Organic Compounds in Groundwater.

Based on pressure test results and review of aerial imagery (1993 to 2020) showing no evidence of spills or releases (e.g., staining or impacted cropland), visual investigation of the flowline corridor is warranted, and the entire flowline alignment will be visually assessed for signs of impact. If any soil staining, vegetation stress, or other indicators of releases are observed, additional soil samples will be collected from those suspect areas for laboratory analysis.

OPERATOR COMMENT

Per the COA on Form 27 Supplemental Document # 404150880 and recent conversations or requests from the State, the approved Form 44, executed landowner agreement to abandon the line-in-place, and most recent passing pressure test are included as attachments. These documents in conjunction with the absence of a spill history associated with this flowline, provide justification for the implementation of a visual inspection of the flowline right-of way in lieu of the COA requested environmental investigation every 250 feet but which is NOT a regulatory requirement for this situation. In addition, Attachment C provides available historical aerial imagery of crops grown above the flowline and demonstrates no impacts to vegetation are present.

A discrete soil sample will be collected from the location where the flowline enters the facility and at the flowline riser adjacent to the former wellhead. Soil sample maps with the proposed soil sample locations are included as attachments.

The wellhead related to this project has been decommissioned and the Implementation Schedule for soil sampling/investigation has been updated. Field work activities will be summarized in a forthcoming Form 27 Supplemental.
