Comment:

The location has not re-established a uniform desirable vegetation cover. It appears the last reclamation work was performed in the spring of 2020. There are areas with mostly undesirable weeds and bare areas with no vegetation. There appears to be impacted soils that will need to be evaluated and remediated. Operator will need to investigate and sample impacted soils per Rule 913. The location will need to be reseeded to establish a uniform vegetation cover. Continue to monitor and maintain the location until the final reclamation requirements are achieved.
