	<p style="color: blue;">Previous Corrective Action not completed.</p> <p style="color: blue;">This location does not meet final reclamation standards. Portions of the access road are predominantly undesirable weeds with little desirable vegetation establishment. The vegetation on the location does not appear to have reached 80% coverage of the reference area and is not reflective of the reference area. Vegetation on the location appears to be predominantly russian wildrye, crested wheatgrass, and smooth brome which were not observed in significant quantities in the reference area. Vegetative coverage on the location did not appear uniform and some portions had lower vegetative coverage with areas of bare soil. See attached photos.</p>	
Corrective Action:	<p>Conduct additional reclamation such as interseeding etc, on the location and access road according to Rule 1004. Establish uniform vegetative cover that reflects pre- disturbance or reference area forbs, shrubs, and grasses with total percent plant cover of at least eighty percent (80%) of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site for weeds, stormwater and reclamation until Final Reclamation has passed.</p>	Date _____
