Comment

Remediation efforts associated with the pits along the southeast end of the Location have been closed, the cutting materials buried and areas reclaimed. Past corrective actions related to reclamation has been resolved and the interim reclamation is considered "in process".

Noxious weeds were observed on the Location; common mullein was observed in small populations within the interim areas on the south end of the Location, and along the edge of the northern WPS. Additional monitoring required to ensure weeds don't continue to spread and establish. Halogeton also observed throughout the WPS. Additional weed management efforts required during the 2026 growing season.
