On 5/28/2025, the potential presence of impacted material(s) was identified via hydrocarbon odor, and hydrocarbon staining during decommissioning activities at the White 1-1; 12-3 27-4; 34-1, 2, tank battery, samples: SEP02-DL. The volume of potentially impacted material(s) is not currently known. Groundwater was not encountered during decommissioning activities. This site is within 300 feet off surface waters of the state. Analytical results of initial soil sampling confirmed the samples are non-detect for BTEXN, TPH, PAHs, SSR, however, 1,3,5-Trimethyl-Benzene and 1-Methyl-Naphthalene exceedance will be addressed in Form 27 Supplemental. A supplemental Form 27 has been submitted for remediation project number 37525 detailing the remedial site plan, document number: 404219853.
