**INITIAL ACTION SUMMARY**

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A site investigation was conducted pursuant to ECMC Rule 911 at the Sater CC 18-17D facility and tank battery location on 04/08/24 and 04/09/24. Grab confirmation soil samples were collected from the base of the produced water vessel (PWV) excavation (FS01@4') and the sidewall exhibiting the highest screening level from the E wall (SS02@3'), beneath the ground oil tanks (AST01@0.5' & AST02@0.5'), and beneath the risers for the flowlines (SEP01-FL@3' & SEP02-FL@3') and dumphines (SEP01-DL@3' & SEP02-DL@3') at both separators. Field screening samples were collected from the N, E, W, & S sidewalls of the PWV excavation (SS01 - SS04), beneath both of the meter houses (MH01@0.5' & MH02@0.5'), and the flare (FLARE01@0.5').

Soil samples were collected as described in the Initial Action Plan section of this Form 27, in accordance with the sampling plan in the Initial Form 27. Decommissioning samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Three background soil sample were collected from a single discrete location at different depths (BG01@0.5', BG01@3', and BG01@4') and analyzed for pH and metals in soil per ECMC Table 915-1. Background soil samples were collected from depths ranging between 0.5 to 3 feet below ground surface (ft bgs) and the background lithology was observed to be similar to that found underneath the tank battery. The maximum background concentration for pH was observed to be 8.71. The maximum background concentration with a 1.25x multiplier applied for arsenic was calculated to be 2.14.

A supplemental site investigation (SSI) will be completed to vertically and horizontally delineate the pH exceedances observed at sample locations AST02@0.5', and FS01@4' during decommissioning. During the SSI, soil samples will be collected and analyzed for full ECMC Table 915-1 constituents. Concurrently with the SSI, additional background samples (BKG02 - BKG06) will be collected to determine if pH and arsenic are attributed to native soil conditions at the site. The Proposed Soil Boring Location Map is attached to this Supplemental Form 27. The SSI will be completed in accordance with the proposed implementation schedule, and the results of the SSI will be submitted on a subsequent Form 27.

Tank battery decommissioning analytical results indicated that organic compound concentrations were in compliance with the ECMC regulatory standards in all soil sample locations. Based on the results for the remaining analytes, a supplemental site investigation will be completed to vertically and horizontally delineate the pH exceedances observed at sample locations AST02@0.5' and FS01@4' during decommissioning. Concurrently with the SSI, additional background samples (BKG02-BKG06) will be collected to determine if elevated pH and arsenic can be attributed to native soil conditions. Sampling will be conducted in accordance with the attached proposed site investigation map, and proposed sampling plan outlined in the Site Investigation Report section of this Form 27.
