Comment The location has been reduced in size and reclaimed. The ripping and seeding were performed perpendicular to the slope except for the northeast side of the location where it appears to be down slope. This is an area of concern that could create stormwater issues. The soils were straw mulched but the mulch cover is sparse and may need an additional application before the growing season. The reclaimed area will need to be monitored and managed to ensure vegetation establishes.
