A site investigation was conducted pursuant to ECMC Rule 911 at the STORER SHOEMAKER T6N-R64W-S12 L01 Facility and Tank Battery location.

Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), at the risers for the flowline (s) and dump line(s) of any separator(s). In addition, the on-site dump lines located between the separator and tank battery were removed by pulling from either end. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Visual inspection at the tank battery area occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses. Additionally, discrete soil samples were collected from the base of the excavation and excavation sidewall in areas most likely to be impacted and exhibiting the highest field screened VOC concentration. A detailed summary of facility decommissioning activities including field notes, site photos, figures, and laboratory analytical results is attached to this Form 27.

On April 22, 2025, three background soil samples were collected from one discrete location (BKG01) adjacent to the tank battery and analyzed for metals in soil per ECMC Table 915-1, pH, SAR, EC, and boron. Background samples were collected from depths ranging between 0 to 4 feet below ground surface. The maximum concentration for pH was observed to be 7.85. The maximum background concentration with a 1.25x multiplier applied for arsenic was calculated to be 1.59 mg/kg. All arsenic concentrations observed during decommissioning were below 1.25x the maximum background level.

The SSI will be completed in accordance with the proposed implementation schedule, and the results of the SSI will be submitted on a subsequent Form 27.

Operator was informed by the laboratory that the sample holding times were exceeded for various Table 915-1 constituents. Because not all analytes would be outside of holding times, the lab ran the samples for the full Table 915-1 suite. The full laboratory report (Report) is being transmitted to ECMC for transparency. The Report's case narrative identifies which constituents were run outside of the required holding times. The Report's note column also identifies the impacted constituents. Decommissioning analytical results indicated that organic compound concentrations were in compliance with the applicable ECMC regulatory standards in all soil sample locations. Based on the remaining analytes a supplemental site investigation (SSI) will be completed to collect additional background samples to determine if pH exceedances observed at sample locations AST01@0-6", AST02@ 0-6", PWV01-B@4', PWV01-S@2', SEP01-DL@2', and SEP01-FL@2' during decommissioning are attributed to native soil conditions at the site. The SSI will be completed in accordance with the proposed implementation schedule, and the results of the SSI will be submitted on a subsequent Form 27.

The implementation schedule has been changed due to the decommissioning of the Shoemaker A12 tank battery and necessity for supplemental site investigation activities adjacent to the tank battery. The proposed site investigation will be completed following the approval of this form and is tentatively scheduled for commencement on 07/24/2025.

This Form 27 is being submitted to include the decommissioning results at the former Shoemaker A12 Tank Battery (Rem# 33845).

Operator was informed by the laboratory that the sample holding times were exceeded for various Table 915-1 constituents. Because not all analytes would be outside of holding times, the lab ran the samples for the full Table 915-1 suite. The full laboratory report (Report) is being transmitted to ECMC for transparency. The Report's case narrative identifies which constituents were run outside of the required holding times. The Report's note column also identifies the impacted constituents. Operator will not be relying on any results associated with a constituent that was outside of the required holding time. Operator will be collecting replacement samples and will be submitting them for analysis. Operator will submit the replacement sample laboratory report in a future supplemental Form 27. The 8260B GBTEXN 915 analyses were analyzed outside of allotted holding times due to delays at Summit Scientific for the soil samples collected during tank battery decommissioning on 04/22/2025.

Tank Battery decommissioning activities occurred at the above referenced location on April 22, 2025. Discrete soil samples were collected from beneath the former facility infrastructure as described in the approved Form 27 Initial document no. 403646270. Tank Battery decommissioning results indicated that organic compound concentrations were in compliance with applicable ECMC regulatory standards in all soil sample locations. Groundwater was not encountered during initial decommissioning activities.

On April 22, 2025, three background soil samples were collected from one discrete location (BKG01) adjacent to the tank battery and analyzed for metals in soil per ECMC Table 915-1, pH, SAR, EC, and boron. Background samples were collected from depths ranging between 0 to 4 feet below ground surface. The maximum concentration for pH was observed to be 7.85. The maximum background concentration with a 1.25x multiplier applied for arsenic was calculated to be 1.59 mg/kg. All arsenic concentrations observed during decommissioning were below 1.25x the maximum background level.

Based on decommissioning analytical results, a supplemental site investigation (SSI) will be completed to collect additional background samples to determine if pH exceedances observed at sample locations AST01@0-6", AST02@ 0-6", PWV01-B@4', PWV01-S@2', SEP01-DL@2', and SEP01-FL@2' during decommissioning are attributed to native soil conditions at the site. The SSI will be completed in accordance with the proposed implementation schedule. The proposed soil boring locations are illustrated on the attached proposed site investigation plan.

Pursuant to Rule 913.e, quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The results of the supplemental site investigation will be submitted on a subsequent Form 27.
