**INITIAL ACTION SUMMARY**

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the WARDLAW 20-28 wellhead cut and cap. The wellhead was cut and capped per ECMC rules. The flowline was previously abandoned PRIOR to the 2018 Registration rules. The flowline is now planned for removal, and the ECMC will be updated in a supplemental Form 27 when a portion of the flowline is able to be removed. Soil samples will be taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway

**PROPOSED SAMPLING PLAN**

**Proposed Soil Sampling**

Will soil samples be collected as part of this investigation? ( Number, type (grab/composite), analyses, and locations of samples ):

A grab soil sample was collected at the base of the excavation. A grab confirmation soil sample was collected at the wellhead excavation. Soil samples will be taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All sample analysis was performed by a certified laboratory using approved ECMC laboratory analysis methods.

If groundwater is encountered, a grab groundwater sample will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB, chloride and sulfate anions and total dissolved solids (TDS).

Six site specific background soil samples were collected from approximately 4 ft., and 6 ft-bgs from three soil borings (BKG01 to BKG03) in areas away from oil and gas infrastructure from similar depths and soil horizons as confirmation soil samples and were submitted for analysis of pH, EC, SAR, and total metals (Table 915-1 List) by ECOM approved methods. **OPERATOR COMMENT**

This 3Q25 Supplemental Form 27 summarizes the decommissioning results of the Wardlaw 20-28 activities conducted on April 28, 2025.

All analytical results for soil samples submitted for analysis are compliant with their respective Table 915-1 Protection of Groundwater Soil Screening Levels or below the highest background concentration for EC (7.36 mmhos/cm) and SAR (10.4) or 1.25x the highest background concentrations for arsenic (7.25 mg/kg) and selenium (0.463 mg/kg), except for barium (134 mg/kg) in soil sample WH01@6.

Noble is in the process of evaluating the residual inorganic concentration at the wellhead. The results of the evaluation will be summarized in a subsequent quarterly Supplemental Form 27.

Additional flowline decommissioning activities will be completed by another consultant and will be summarized in a subsequent Supplemental Form 27 submittal.

Please refer to the attached initial site investigation assessment and analytics for a detailed description of activities conducted during wellhead decommissioning. The data were reviewed for compliance with the analytical method and the associated quality assurance/quality control (QA/QC) procedures. Chain of custody forms were properly executed, and data were reported using the correct methods and reporting units. The results of the QA/QC assessment indicate that data precision and accuracy are acceptable.

Pursuant to Rule 913.e, quarterly reporting will continue for the location until data indicates no further action is warranted.
