INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the LUCCL B01-22 flowline removal. Approximately 1467' of flowline was removed. Additionally, soil samples were collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. The ECMC was updated in a supplemental Form 27 if a portion of the flowline is abandoned-in-place due to field constraints.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample were collected at the base of the excavation or the area showing the highest degree of impact during field screening activities. Additionally, soil samples were collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Eighteen background soil samples were collected from an area not impacted by oil and gas development and at similar depths and lithologies as confirmation soil samples collected at the location and analyzed for Table 915-1 metals and SSR constituents. Background soil sample analytical results were reported with elevated levels of arsenic, barium, cadmium, pH, EC, and SAR.

Elevated lead concentrations exceeding the Table 915-1 PGSSLs and background concentrations were observed along the LUCCI B01-22 flowline at the FL02 3 Ft sample location. Soil will be resampled and analyzed for the full suite of Table 915-1 soil constituents at the FL02 3 Ft sample location at the same depth where the initial elevated lead concentration was observed. Noble will request an NFA be granted if the reanalyzed samples comply with the Table 915-1 concentration standard. Background samples will be used to justify elevated concentrations.

Additionally the Operator will sample along the LUCCI B01-22 flowline at previously field screened locations FL08 3 Ft, FL11 3 Ft, and add and additional sample location FL12 3 Ft to comply with the sample locations proposed on the site map attached to initial Form 27 for the project.
